## **Meeting Minutes**

February 21, 2017

#### • Call to order

## • Zoning Inspector's Comments and Suggestions

## New Business

Kim brought up the fact that the township's zoning inspector has not been at the zoning meetings for 3 months. Her concern is that he is the commission's link to the township's zoning issues. With the zoning resolution undergoing changes and reorganization, the inspector's input would be helpful.

The committee and trustees then discussed with Gary some frustrations about encouraging the county prosecutor's office to enforce township issues.

## • Comments from Gary Smith Regarding Zoning Resolution Update

Gary continued discussion about signs in our community. Most of our resolution changes are a reorganization of current information into an order that will be easier to read. He recommended the following changes:

Applications for approval of signs needs to have a due date that is enough in advance to receive a recommendation from Regional Planning before the next zoning meeting in order to meet the O.R.C.

Off-premises signs should be a temporary sign (1 month or less), otherwise it would fall into the billboard category.

Temporary signs for community events could be available at little to no charge to encourage people to get a permit and should be good for 45 days.

A property that is for sale and has frontage on two roads should be allowed a sign on each road frontage.

Store open/hours of operation signage should be allowed with no permit as long as it does not exceed 4 sq. ft. to encourage good business/customer relations.

Electronic signs to include outdoor video screens, billboards and digital signs need more regulation than we currently have. This area is increasing in scope as technology grows, so we need to plan for future expansion. Gary will look into Ohio regulations for brightness and time limits on digital signs.
