FIRE DEPARTMENT BUSINESS

Interim Fire Chief Schultz said Carlton Reaves & Jonathan Bainter were recognized at the annual blue coat awards.

We had 2 firefighters attend the BWC Ohio Safety Conference and come back with good information and ideas.

Interim Fire Chief Schultz updated the Trustees on the front-line fire truck annual checkup and maintenance and during that time our backup truck had an issue with a fitting and wouldn't hold water. We borrowed a truck from Pleasant Township which has been returned with gratitude and we have our front-line truck back but the backup truck is still in the shop.
