The Greenfield Township Trustees met in special meeting session at the Greenfield Township Firehouse regarding the appointment to fill the vacant position of Township Fiscal Officer, vacated March 12th. Trustee Sitterley called the meeting to order at 6:30 pm. Trustees Dave Cotner, Lonnie Kosch, Jennifer Sitterley were in attendance.

**Special Meeting**

Entered into executive session for personnel discussion at 6:30 pm

Exited executive session at 6:45 pm

**Public participation**

Kyle Gleich: asked about circumstances surrounding prior Fiscal Officer stepping down and whether any investigation occurred. Raised concerns regarding trustee accountability and potential toxic work environment.

Kosch: Trustees did not push Fiscal Officer out; stated litigation relates to public records requests. Mentioned it's on Facebook now, Danielle Keefer posted that there was a lawsuit, litigation against us. The litigation was public records. Litigation for not getting public records. Additional details will be addressed with legal counsel.

Cotner: stated no harassment occurred and indicated excessive public records requests created operational burden.

Gleich: Questioned transparency of appointment process and candidate qualifications.

Kosch: Explained personal outreach to candidates and interview efforts. Reached out to all three candidates, Keefer and Wyne responded for interview, Bichard did not respond to email.

Sitterley: Stated familiarity with candidates and prior discussions with each.

Cotner: postulated that only one candidate would speak with him.

Trustees identified candidates as Danielle Keefer, Angel Bichard, and Dawn Wyne.

Bichard affirmed she will support the United State Constitution and the State of Ohio Constitution and faithfully discharge duties.

Cotner: Second
