Proposals for language changes discussed (to include, but not limited to):

- Accessory Uses remove 340.3, #3, section on Dwelling Units
- Rename Service Stations to Gas Stations and move to Permitted Use and retain Conditional Use language 'approval requirement by the Greenfield Twp Trustees'
- Permitted Uses to match across both documents
- Retain personal storage warehouse section
- Retain Minimum Development Standards as listed in B1
- Move Rear Yard to 345.03 #3 to Accessory Uses #4
- Minimum Lot Width change to 150 ft. and add language 'where public water and sewer are available'
- Edit Height language to 35 ft. and remove Stories requirement
- Retain lighting language this section for further review
- Retain Trash and Garbage Control section
- Landscaping/Buffering this section for further review

June Queen to write up revised sections and provide to commission members for review and further refinement.
