Meeting

June 26, 2019 *Held* 7:00 PM

The Greenfield Township Trustees met in regular session at the firehouse. Kent Searle called the meeting to order and led those present in the Pledge of Allegiance. Dave Cotner, Lonnie Kosch and Kent Searle were present.

After each trustee reviewed the minutes from the meeting held on June 12, 2019, Trustee Cotner made a motion to approve the minutes as written; Trustee Kosch seconded the motion. *ROLL CALL: Cotner: yes Kosch: yes Searle: yes. Motion Passed 3-0.* 

### FROM THE FISCAL OFFICER

The Fiscal Officer passed out various pieces of correspondence and the financial reports.

Trustee Searle made a motion to approve the financial reports; Trustee Cotner seconded the motion. ROLL CALL: Cotner: yes Kosch: yes Searle: yes. Motion Passed 3-0

Trustee Kosch made a motion to pay the bills associated with warrants 33007 - 33035 and electronic debits 66-2019 – 69-2019; Trustee Searle seconded. *ROLL CALL: Cotner: yes Kosch: yes Searle: yes. Motion Passed 3-0* 

Fiscal Officer Wyne advised since the legal ad could not be posted timely for June 26, she would need to change the Budget Hearing to July 10 at 6:45 p.m.

Fiscal Officer Wyne stated in March she met with Amber Stein, our AFLAC representative they discussed the cancer policy and it became parent that the Township has three different policies. An old version in which 4 individuals are on, Classic in which 6 individuals are on and the Premier in which 3 individuals are on. Currently the township is paying \$9,904.44 a year. I was advised if everyone is on the Classic level it would be \$9,687.60 and if everyone is on the Premier level it would be \$13,317.72. I believe since the Township is paying for this policy everyone should be on one policy. Trustees requested that this issue be tabled until the next meeting.

## **FLOOR**

Debbie Fisher, 1903 Rainbow Drive, stated she was here two weeks ago and since then she has talked with the Sheriff's office. The Sheriff advised they are going to start patrolling more. She also has concerns with all the run off. She cleaned out the catch basin at the top of her drive last Saturday and it has filled back up. Stated that she had dug a trench in the township right of way to help divert the water. She stated there are wires where she dug and that will need addressed.

Kevin advised he is working with IWorks and the software is currently being built. We will probably go live the end of July.

Kevin stated he got a call from Jerimiah regarding Rock Mill Brewery. The brewery bought a property across from it, tore down the house and put in a lot of gravel. Kevin suspects they made parking for the construction workers. Trustee Cotner will talk to the brewery.

Trustee Kosch asked if the zoning commission received the zoning books. Kevin advised yes.

### FIRE DEPARTMENT BUSINESS

Chief Smith advised engine562 is at Thurston because their engine is getting repaired and should be back by Friday.

Chief Smith stated he attended a 3-day ride along training session for the Community Paramedicine at Upper Arlington. They suggested he start talking to the patients, kind of a grass roots type of thing instead of utilizing the hospitals at first. They said to build it from the bottom up, talk to the patients and then eventually get the hospitals on board. Chief Smith said it was good to see the proper steps to getting this program started and that he will be meeting with a patient next week.

Chief Smith advised he is working on a partnership with The Ohio State University for Community Paramedicine. They are willing to help write grants to help with equipment for us.

All of our MARCS radios arrived as of June 20, 2019. Chief Smith advised that the township has received an extension from the Fire Marshall until September 1. All the bills for the radios had to be paid by July1st and we have not received the invoices and that is why Chief Smith asked for the extension.

Trustee Cotner asked if the Trustees should make a motion for the Road Department to pay the Fire Department \$1.00 for the old medic. Trustee Kosch stated Violet Township had to pay \$1.00 when their Fire Department transferred a truck to the Police Department. Fiscal Officer Wyne asked if their Police Department did work in exchange for the truck like our Road Department is doing for our Fire Department. Trustee Kosch didn't know. Fiscal Wyne will check into this.
