The Greenfield Township Trustees met in regular session at the firehouse. Dave Cotner called the meeting to order and led those present in the Pledge of Allegiance. After each Trustee had reviewed the minutes from the previous meeting of August 9, 2017, Trustee Reef moved to approve the minutes; Trustee Kosch seconded, and all voted yes.

# FROM THE FISCAL OFFICER

The Fiscal Officer passed various pieces of correspondence and the Financial Reports.

Trustee Cotner moved to approve financial reports; Trustee Reef seconded, and all voted yes

Trustee Reef moved to pay the bills and the Payroll Electronic debit associated with warrants 31887 through 31912 listed on the attached Check Register, Trustee Cotner seconded, and all voted yes.

Carla spoke to Glenn Anderson with TCR about Kevin's computer. Glenn suggested that we just replace the drive. This revenue can be used to build schools, fire stations, recreation center, etc., anything except personnel. Trustee Cotner wants to move forward. Kevin will talk to Mayor Drobina to see if the Village of Carroll might be interested and to set a date for Mr. Ricketts to speak to Village of Carroll.

### ZONING BUSINESS

Kevin did not have reports to pass out.

Regional Planning sent application for a lot split on 158. Trustee Reef questioned how a home was built with no road frontage. Kevin will check into this.

Trustee Kosch questioned previous high weed issue which Kevin stated he has not checked out yet.

Trustee Reef moved to approve the position description for Zoning Inspector and it was seconded by Trustee Kosch. All voted yes.

Kevin stated that at the BZA meeting it was decided that John Starner will be taking the minutes. Kevin asked the Board if he should be paid an additional \$25.00 per meeting to take the minutes. Trustee Kosch moved move to pay Mr. Starner the additional \$25.00 and seconded by Trustee Reef. All voted yes.

### FIRE DEPARTMENT BUSINESS

Chief Schwinne advised that the sign was removed from the old fire station in the village. He also advised that he still needs to remove and change locks. Chief Schwinne advised that the Road Department should be able to move in equipment by end of month

Chief Schwinne changed the outside lights that are on all night to LED but they have not found ones for the flag pole and parking lot that are able to send light a long distance to light up the flag and parking lot. The new LED lights use 18 watts each and the old lights we changed ranged from 100 to 175 watts each. The next phase will include changing out the rest of the interior lights and the bay lights.

Chief Schwinne stated the Carroll Community Festival was a great turn out from the Fire Department and the Community. We want to say," thank you for all you do!"

Chief Schwinne stated that the Smoke Detector Canvas is August 26 from 10:00 a.m. to 4:00 p.m. in the Village of Carroll.
