After each trustee reviewed the minutes from the special meeting held on August 22, 2019, Trustee Cotner made a motion to approve the minutes; Trustee Kosch seconded *the motion.* ROLL CALL: Cotner: yes Kosch: yes Searle: abstained Motion Passed 2-0.

FROM THE FISCAL OFFICER

The Carla Jacobs passed out various pieces of correspondence and the financial reports.

ZONING DEPARTMENT BUSINESS

Kevin passed out the fee and collection reports.

Kevin stated he had sent out 2 letters for property cleanup. One for 1835 Carroll Southern and the other for 1425 Coonpath and has not had any response from either and didn't know if any trustee has received a response. Kent stated that Fiscal Officer Wyne will type up the resolutions to move forward on these properties at the next meeting.

Trustee Kosch asked if Kevin had contacted the company about the new software and the adjustment of his hours. Kevin said no, he wants to get through the BZA hearing first.

Trustee Kosch also asked about the trailer on Old Columbus Road. Kevin said there must be 2 of them because they have moved the one and Kevin also said the Health Department is involved in this. Kevin said the Chief Smith had contacted him to ask if there was anything Kevin could do to help with this because this is where Cory Spires got injured.

Trustee Kosch talked about the signs at Hooker across from the used car lot and where the asphalt grindings are, he has a bunch of new signs in there. Trustee Kosch asked if there were permits for the signs, Kevin said no. Trustee Kosch asked him to check on them and the man's name is Jim Cox. Chief Smith said the Sheriff is also familiar with that address.

FIRE DEPARTMENT BUSINESS

Chief Smith asked for a motion to accept the resignation of part timer Fred Murray due to the fact that he got a full-time position with Pleasant Township effective 8-31. Chief Smith stated they ordered and are starting to receive some of the Handtevy equipment that is from the Shriner's grant money.

Chief Smith stated that they are working on talking to a grant company on helping with applying for the FEMA grant that comes up in October. We are looking to replace ort air packs, our SCBA's and the Cascade system. The fill station is 30 years old and has seen a lot of use, it still works, but being that old we will start having problems getting parts to repair it. If we do get the grant, it would save the department \$130,000 to \$160,000. There is a charge to use the grant company. One level is \$1500 and we do most of the work, they review and critique and will give advice on changes needed. Another level is \$2500 and they do it all, write it, submit it and they will write into the grant up to \$1500 for reimbursement for them writing it so it would only cost us \$1,000 if we get the grant. There is no guarantee that even if we use a grant company that we will get the money. Motion made to spend the \$2500 for the grant company to prepare the paperwork for the FEMA grant by Trustee Cotner; seconded by Trustee Searle.

Chief Smith reported they have been approved for the Speedway Super Fleet card.

The Carroll Community Festival had a good turnout. People enjoyed spraying the water and Violet Township provided the department with their CPR trailer and that gave people hands on experience.

Chief Smith stated that starting September 10^{th} , he will be going to 3 days of training for QRT (quick response training) for drug addicts and alcoholics. He will potentially be on this team to go out on call with police, detectives and medics.

Trustee Kosch told Chief he thinks the Facebook page looks great. Chief Smith said it is Theresa Inman that has created and maintained the page.
