o News on Speed studies in the queue this year with different roads

- Shafer: Old Columbus Rd I printed the original resolution for permission to proceed with the County to do the study and printed off the report by Eric McCrady from the Engineers office. It's a good read email attached. The short version is that data collected by the County Engineer submitted to ODOT (who has the final say on speed posting on township roads) they set up a speed limit tailer, collected average # of cars, speed, and the lowest ODOT posting is 50 MPH. (The current speed limit is) already 55 (not posted). I agree with Eric 100% we do not act on posting sign at 50 MPH majority of traffic already averages below that, if we post it that'll encourage traffic to speed up
 - Cotner the average speed (from the study) is 44 MPH
 - o Williamsen I'd like a copy, it'll come up in zoning
 - o Cotner it already did
 - Shafer I need to tell Eric how to proceed
 - Cotner I agree with the recommendation (not to post)
 - Shafer: don't think the board needs to sign off, just stop the study
 - o Searle- (there is) no advantage to reduce by 5 MPH
 - o Kosch agree
 - Cotner we all agree to stop the study
 - Kosch do you need a motion? (It will) be in the minutes

 - Wyne but don't let it sit there
 - Searle I agree, but we did address what is in bank account in special meeting last week, and we brought it up and Jessica (Kull) was there. She said she'd rather address it at next meeting and will give an amount to keep in there and what to move
 - Wyne what you have (in there now) will cover almost two years
 - o Searle I'm not sure what to recommend without the fiscal officer
 - Wyne –(to Shafer) what have you paid for flooding so far?
 - Shafer: I've paid what we've been appropriated
