Fiscal Officer Wyne distributed a part-time roster of hours for the Fire Department. Chief Smith stated this was due to the fire spreadsheet not calculating correctly.

Fiscal Officer Wyne stated that she received a call from a resident, Amy Smith, inquiring if we could make a resolution to not permit Canal Street to be a main access road to get to the field behind that road. Fiscal Officer Wyne advised that Tom Shaffer did bring this up at a trustee meeting but as far as she knew, there had not been any decision made. Fiscal Officer Wyne advised Ms. Smith to get ahold of the trustees. Trustee Kosch stated that if this is an abandoned road, the township has no authority over that road; it would be the landowner's decision.

FIRE

Chief Smith stated there was not enough money from the CARES Act money to completely cover the cost of the HVAC system. The balance will have to be paid out of the fire budget. Motion made by Trustee Cotner for payment of the HVAC system from Fire funds up to \$20,000.00: seconded by Trustee Searle.
